**REINSTATEMENT OF CERTIFICATE FOR FOREST MANAGEMENT CERTIFICATION  
(MC&I SFM) ISSUED TO RAVENSCOURT SDN. BHD.**

With regards to the above matter, please be informed that SIRIM QAS International has made a decision to reinstate the Certificate for Forest Management Certification MTCS ST 1002:2021 (MC&I SFM), Certification No. **FMC-NF 00116** issued to the **Ravenscourt Sdn. Bhd.** with effect from the date of this letter.

Based on the decision from the Appeal Panel, a Special Audit was conducted on 4 – 6 December 2023. The purpose of the Special Audit was to review and confirm the evidence required for the closure of the 2 Major NCRs raised during Surveillance audit (SA1), which had triggered the withdrawal process for the Ravenscourt FMU certification.

During the Special Audit, the auditors had concluded that both the pending NCRs can be closed and the certificate to be reinstated and the audit cycle shall resume accordingly. The closure of the NCRs conducted based on clarification and definitions obtained from MTCC, which was used as a guidance to address the findings, consultations with relevant and specific stakeholders and review of pertinent records.

Please kindly be informed that in following our accreditation requirements for reinstatement process, the audit cycle has to be realigned and therefore the next Surveillance audit 2 (SA2) for Ravenscourt FMU has been scheduled on 15 – 19 January 2024 and Surveillance audit 3 (SA3) shall be conducted in 2<sup>nd</sup> Quarter of 2024.

As part of our audit process as well, we will be conducting the stakeholder consultation for all the affected stakeholders accordingly. Therefore, kindly do confirm the audit dates to ensure the audit cycle can be resume accordingly.
